Well location- there is some desirable vegetation observed throughout the well location but will remain in process. There were some prairie dog holes observed at the well location.

Access road- access road is pre-existing prior to oil and gas operations- see Photo 4. The access road is stabilized throughout.

The associated tank battery will be addressed with another nearby well location.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct inspections prior to receiving said notice to ensure compliance with Rule 1004.
