Previous inspection observed Oil and Gas associated utility lines/poles leading to the Location have not been removed. It was also observed that a section of access road, and likely culverts, constructed within a drainage has not been reclaimed. Inspection required Operator to comply with Rule 1004.a.

It was observed in this inspection that equipment has been removed, and access road has been recontoured; Corrective actions have been addressed.

Final Reclamation in process. Continue to monitor/manage reclamation until site receives a passing final inspection. Conduct additional work as necessary to ensure site progresses towards 1004 standards.
