It was observed in this inspection that interim areas appear to be colonized by annual, non-native, undesirable plant species/weeds. Vegetation observed in the interim areas included cheatgrass, kochia, mustard spp. and annual wheatgrass. Perennial grasses were observed to be sparse.
