Gentlemen:

Pursuant to Rule 305.b. of the regulations of the Oil and Gas Conservation Commission of the State of Colorado, Vessels Oil & Gas Company would like to commence dirtwork for the drilling of the captioned well on or about September 15, 1996, pursuant to its oil and gas lease. This location will be staked on the lands described above at a location within the area allowed for a legal drilling site as determined by the rules of the State of Colorado Oil & Gas Conservation Commission.

We would like to afford you or your representative the opportunity to meet at the site, if you so desire, to hear any concerns you might have and to discuss how we might place the road, pipeline, production equipment and drillsite so as to minimize the amount of land used and best complement you present and proposed use of the surface within the restrictions imposed on us by the Commission.

Enclosed is a plat illustrating the proposed location of the drillsite and access and a diagram of a typical drillsite. The final determination of the location and dimensions of the drillsite, the production facility, flowline, access road and other areas to be used in the operations will be provided at a later date and will be the subject of the consultation process referred to above. I will be representing Vessels Oil & Gas Company, the operator of the well, and any correspondence or contact with us may be made with me at 1600 Stout Street, Suite 1200, Denver, Colorado 80202 or by phone at (303) 893-1000.

Please return the enclosed prepaid postcard at your earliest convenience, indicating you desire to waive or proceed with the consultation I have described. If you have a tenant and would like him involved in the consultation process, Vessels will be happy to accommodate you. Because of the difficulty on the part of the operator in determining the existence of tenants, however, the State of Colorado places the responsibility on the surface owner of notifying the tenant of oil and gas activities. If you would like a consultation, simply indicate the name and appropriate information on how and when to contact you on the enclosed postcard. We look forward to working with you and thank you in advance for your cooperation.

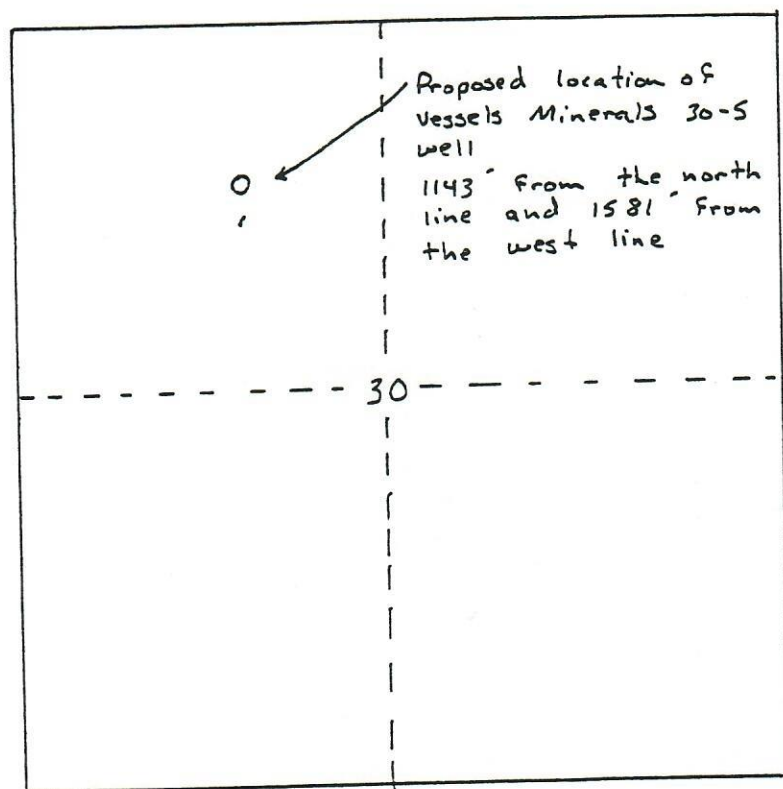

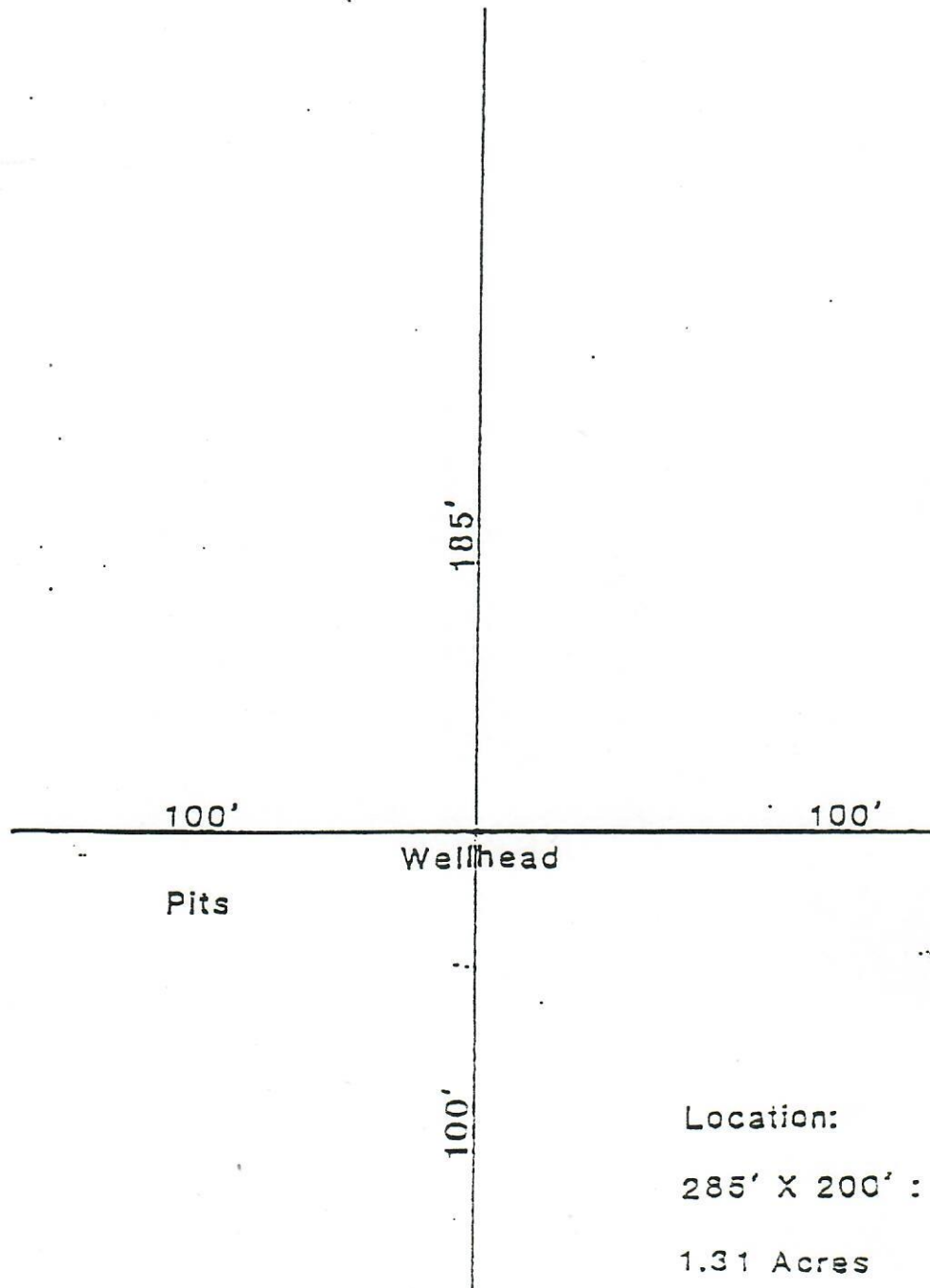
