

Dear Mr. Feuer:

We anticipate the commencement of dirtwork for the drilling of the captioned wells on or before November 15th, 1994 to explore our mineral ownership. These locations will be staked on the lands described above at locations within the area allowed for legal drilling sites as determined by the rules of the State of Colorado Oil and Gas Commission, as shown on the attached map.


In order to minimize the amount of future reclamation and present disturbance to your use of the surface, I would like the opportunity to meet with you or your representative at the site to discuss the placement of the roads, pipelines and drillsite so as to minimize the amount of land used and best complement your present and proposed use of the surface. I have proposed access to the location on the enclosed map which may or may not work for you and which we can adjust to meet our mutual needs.

In preparing for the meeting, I am also enclosing a map showing the typical dimensions of a drillsite pattern for your review.
