Comment:

The cattle guard remains at the beginning of the access road and the fence has not been installed back to the original position. The fence at the location needs to be repaired at the wire gate. The undesirable vegetation has been mowed since the previous inspection. There are undesirable weeds throughout the location and minimal desirable vegetation establishment. It is unknown if reseeding has occurred. The weed debris may interfere with reseeding effort. The undesirable weeds will need to be controlled and desirable evegation will need to be reestablished.
