There is no subsequent Form 6 in the well file which was due within 30 days after abandonment. Previous corrective action has not been completed. Corrective action needs to be performed immediately to obtain compliance.

There does not appear to be desirable vegetation establishing along areas of the access road or location. The location consists mostly of undesirable weeds. Additional reseeding will need to be performed before this upcoming growing season. The undesirable weeds will need to be controlled and desirable vegetation will need to be reestablished.
