Form 4 for TA Status 402845375 dated 10.18.2021 Approved by Steve Jenkins on 10.29.2021. On this Form it states that the last MIT was on 08.14.2021. AGAIN NO Form 21 on Record to correlate to an MIT being done on Well.

Only a Form 17 (Bradenhead TEST) date 09.02.2021 with a the Test date of 08.14.2021 is on Record.

Form 17 - Bradenhead Test and Form 21 - MIT (Mechanical Integrity Test) are NOT the SAME THING.

Last MIT performed on Well appears to be done on 01.28.2014 per Form 21 2477083

Form 4 402845375 also states Well to be Plugged and Abandoned in the Future. Well plugging requires an approved Form 6 Intent to Abandon to Plug Well.
