WHEREAS, between the dates of May 2, 1940 and September 23, 2009, access roads, well pads, and facilities were constructed and wells were permitted and drilled by **EQUITY OIL COMPANY**, whose address was: Utah Oil Building, Salt Lake City, UT, on the lands presently owned by **MMGJ COLORADO, LLC, a Delaware limited liability company** (hereafter "MMGJ") whose address is 13727 Noel Road, Suite 1200, Dallas, TX 75240

E2NE1/4 Sec. 6-T1N-R102W; E2E2 Sec. 31-T2N-R102W (with other lands), of the 6th P.M.: Rio Blanco County, Colorado. Containing **830.221** acres, more/less. (**Parcel #1383-323-00-001**).

AND WHEREAS, effective September 23, 2009, **EQUITY OIL COMPANY** formally merged with **WHITING OIL AND GAS CORPORATION, a Delaware Corporation** (hereafter "WOGC"), vesting all right, title and interest and contractual obligations for the stated roads, wells, and facilities in WOGC.

AND WHEREAS, WOGC intends to plug and abandon the wells identified herein and reclaim the well locations and general areas in accordance with the Code of Colorado Regulations – 2 CCR 404-1 – Rules 305, 306, 316, and 1004 – Well Site Reclamation, and according to MMGJ preferences,

NOW THEREFORE, for valuable consideration in hand paid, this Agreement is entered into by and between the owner in possession and use of the subject lands, **MMGJ COLORADO, LLC**, whose address is: **13727 Noel Road, Suite 1200 Dallas, TX 75240**, and **WHITING OIL AND GAS CORPORATION**, whose address is: **1700 Lincoln Street, Suite 4700, Denver, CO 80203**, in order to fulfill contractual obligations of reclamation and achieve the release of all claims between the parties related hereto.

Upon receipt of payment and satisfactory completion of the reclamation actions described below, MMGJ shall execute and deliver to WOGC an AFFIDAVIT AND RELEASE.

RECLAMATION ACTIONS:

I. Clean up: All trash, foreign objects, cuttings and waste materials will be removed from the site. Disturbed areas will be naturally contoured and reseeded according to MMGJ preference.

II. Well bore and location:

WOGC shall plug and reclaim the subject well according to Colorado Oil & Gas Conservation Commission specifications ("COGCC"), as approved and overseen by the COGCC.

III. Waiver of liability:

WOGC shall hold harmless, defend and indemnify MMGJ from all environmental claims that arise in connection with the subject reclaimed well locations.

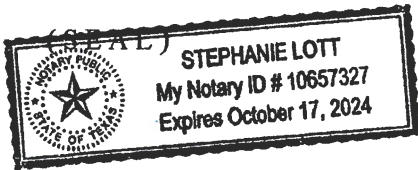

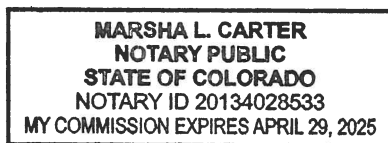
