Operator Comments:

The subject well was originally drilled and Operated by Pine Ridge Oil & Gas to test the Niobrara and Pierre formations in 2010. The Niobrara, 3944'-4514' proved to be non-productive and was abandoned 7/01/2010 with a 265' cement plug, tagged at 3870'. Date of first production from the Pierre was 7/21/2010 and drastically declined, causing the -00 wellbore to be abandoned 1/26/12 with plans to side-track the wellbore. The successor operator, Incremental Oil & Gas abandoned the -01 Pierre sidetrack, 2380'-4376', on 2/27/2013 when efforts were compromised with unstable wellbore integrity, which caused the directional drilling tools to be lost downhole. Fishing efforts at the time were unsuccessful. Records could not be recovered to indicate if and when a bridge plug was set at 1980' but an MIT conducted by Incremental on 4/15/16 noted that a bridge plug was at 1980'. No physical records could be found setting the bridge plug but notations on wellbore diagrams referenced a BP at 1976'. Recollections by previous Incremental employees also indicated a bridge plug had been set in the wellbore.

The next successor operator, AusCo Petroleum Inc. evaluated the well for potential re-entry to retrieve downhole tools. AusCo conducted an MIT on 11/18/21, and prior to testing, tagged plug-back at 1980' with a sinker bar run on a sandline.

This Sundry Form 4 serves as notice of continued Temporarily Abandoned Status. AusCo has deemed this well to have no additional opportunity and plans to file a Form 6 Intent to plug and abandon the well in November or December 2022. Final reclamation and reseeding will be further conducted upon a successful P&A.

- MITs were conducted 4/15/16 and again 11/18/21.
- Valves on the wellhead are closed.
- Prior operator conducted interim reclamation, ripping and reseeding on 10/01/2016.
