The Domestic Water Well (DWR Receipt # 0465983) approx 570-ft to the SE is the nearest permitted water well. This well was never constructed. The planned construction depth and static water level were not recorded. Domestic Well (DWR Receipt # 0465993, Permit 229379-) is approx 1120-ft to the SE. This well was constructed to 260-ft, with a static water level of 41-ft. Domesic Well (DWR Receipt # 396016, Permit 192916-) is approx 1275-ft to the SE. This well was constructed to 260-ft with a static water level of 51-ft.

Groundwater less than 20 ft is not expected at the disturbance location.

This location is within ¼ mile of a HPH Pronghorn Winter Concentration Area.

A site investigation will be conducted pursuant to COGCC rule 911 at the Dutch Lake 9-11H oil and gas location (422932) pertaining to the cut/cap of the Dutch Lake 9-11H wellhead (API: 05-123-33450), removal of all on-location flowlines, including wellhead line, and decommission of production facilities. Grab confirmation soil samples will be collected from beneath the above ground oil tank, water tank, separator, and wellhead. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, metals, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
