The soil stockpile on the west of the Location is densely colonized by weeds, including cheatgrass, purple mustard and alyssum spp. A follow up inspection will be conducted later in the growing season to determine if the Location is progressing towards 1003 standards.

STORMWATER COMMENT #1 Previous inspection #700704039 observed Location and access shows some signs of lack of stabilization/ compaction/ degrading and cut slope is not stabilized and shows signs of erosion. Inspector required Operator to install or repair required BMPs by 5/13/2022. It was observed in this inspection that the Location shows signs of lack of stabilization BMPs in some areas, as is evidenced by the presence of ruts. No evidence of BMPs to minimize/mitigate tracking and offsite sediment transport. It was observed in this inspection that control measures to protect and stabilize the slopes on the east of the Location were missing or insufficient. A single straw wattle has been installed at the center of the slope. It was observed that there was undercutting and lateral erosion of cut slopes resulting in soil loss, exposed roots, and vegetation loss from the adjacent native plant community off-Location, which the wattle does not appear to address.
