Once a release was discovered during inspections on the condensate tank at the Kennedy NWNE Multiwell Pad (Location ID: 446799), additional excavations were conducted, and impacted soil was removed and transported to a disposal facility. Soil samples will be collected and analyzed for Table 915-1 constituents until the horizontal and vertical extents of the excavation are within COGCC Table 915-1 allowable limits.

Grab soil samples will be collected and field-screened from the base and each sidewall of the excavation. Soil samples will be collected and analyzed for Table 915-1 constituents until the horizontal and vertical extents of the excavation are within COGCC Table 915-1 allowable limits. Background samples will be collected from nearby native soils in areas not impacted by oil and gas activities and analyzed for EC, SAR, pH and boron to establish background conditions for soil suitability.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during excavation activities, one sample will be collected and analyzed for Table 915-1 groundwater constituents BTEX, 1,2,4 and 1,3,5 Trimethylbenzene, and naphthalene.
