Hello Ms. Murphy,

I have been working with the COGCC staff, Patara Oil and Gas (my client), and Paradox Resources in the hopes of releasing Patara's bond. I am at a dead end and could use some help. Here is a brief summary of what we have completed over the past 2 years:

- Patara has reclaimed 6 sites and passed all inspections
- Patara and Paradox have worked together to clear up any remaining database issues that didn't transfer with the bulk sale of properties from Patara to Paradox.
- We have waited for 6 months for an answer from COGCC regarding the release of the bond after being told that we had successfully remediated each impacted property or had successfully transferred each property to Paradox.

Today we received communication from Ms. Lutz stating that we still have a technical issue regarding one property. I was told to contact the appropriate COGCC employee to resolve this matter. Unfortunately I don't have anyone else to contact. Mr. Hughes and Ms. Roy have been responsive and very helpful during this process, but they are unable to solve our problem.

I've attached the relevant email chains for your information.

Can you point me in the right direction? Patara and Paradox have done everything by the books. Any help would be greatly appreciated.

Thanks for the quick response. We have emailed about this issue before, a Form 9 was filed during the property transfer when Paradox bought the properties from Patara. I don't believe the system will accept two of the same forms for the APN listed. The issue lies with the system not accepting the Form 9 for the "location" only with the "well". We need to expedite this process since its been months of back and forth. Filing another form and waiting 6 months for the Financial Assurance team to review isn't reasonable.

Can you look into the historical documents and see if the original Form 9 covers both the "well" and "location"?

If we need to set up a call to get all of the details hammered out I can facilitate that.

Thank you for your inquiry. I have discussed this situation internally with Jarrett Ellis, COGCC Finance Manager (now copied into the distribution list), and we have an administrative solution.

Form 10 doc # 400627560 was submitted June 17, 2014 and approved June 25, 2014 (effective date November 1, 2012). This form transferred well API #085-06049. The Oil and Gas Location (Number 313643) was not included as a line item on the form and did not transfer. A Remediation Project (REM #5731) to close the drilling pit in accordance with applicable rules at the time of pit closure was transferred through the submittal of a Supplemental Form 27 (document #402754199). The Form 27 included the same background information that was submitted on the Initial Form 27 (document #2213764). Both Form 27s included a Condition of Approval related to reclamation of the site, which according to COGCC rules, is not complete as of the last inspection on May 10, 2021 (Field Inspection Report document #688800009).

Form 10 doc #2210642 was submitted December 8, 2015 and approved December 18, 2015. This form transferred well API #113-06173. The Oil and Gas Location (Number 399752) was not included as a line item on the form and did not transfer. This well is currently listed as Temporarily Abandoned, and the Location as Active.

Due to this administrative issue, created years ago, COGCC can update the records for these 2 locations and complete the transfer from Patara Oil and Gas LLC (operator #10332) to Paradox Upstream LLC (operator #10453).

**In order to do so, I need a reply in the affirmative from representatives of both companies that you agree to retroactively include Location #313643 and Location #399752 in the previously executed transfers documented in the above referenced Form 10s.** For the purposes of this action, a representative must be listed on a Form 1 or 1A for the company.

Upon receipt of those responses, COGCC will update the records appropriately with this communication included in the files.
