Comment It was observed in this inspection that revegetation success varies across interim areas of the Location. Overall interim areas are colonized by perennial grasses, scattered rubber rabbitbrush, sagebrush and curlycup gumweed. The western interim area of the Location is dominated by annual invasive weeds/undesirable plant species including pale madwort, cheatgrass, bur buttercup and Russian thistle with minimal perennial grasses. A follow-up inspection will be conducted later in the growing season to determine compliance with 1003 requirements.
