INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Digging for backfill off location, the Satellite Header 38 bulk line was struck by equipment. Line is 6 in diameter and was approximately 4 ft deep. Line was isolated immediately and all proper notifications were made. A temporary berm was built to contain some liquids. The spill path was water washed. All fluids went to land and entered a dry drainage feature which led to Chevron Siphon 23. Approximately 284 cu. yds of impacted soil was removed from siphon 23 and transported to the Rangely landfarm in November 2021.

Preliminary soil samples were collected from beneath the repaired flowline on November 23, 2021 and on November 30, 2021 and December 7, 2021 from the spill path. A total of eleven (11) grab soil samples analyzed for Table 915-1 parameters were collected at depths ranging from 0 to 4 feet below ground surface. Results show elevated TPH at the SS1 location and elevated SAR, EC and pH at select locations throughout the entire spill path above the Table 915-1 Residential Soil Screening Level (RSSL).

The upper 1 foot of hydrocarbon impacted soil around the SS1 sample location will be removed and hauled to the Rangely Landfarm for treatment. The remaining inorganic exceedances to the Table 915-1 RSSL will be remediated under monitored natural attenuation.
