Comment Revegetation is progressing within portions of the interim reclamation areas. However, patches of ground in the northern reclamation area support little desirable vegetation and may be salt affected. Scattered Russian knapweeds were observed. As it is early in the growing season, additional individuals are likely present. Operator needs to assess vegetation and manage weeds in 2022. Soil sampling/remediation may be needed in areas where sparse desirable vegetation is present, and weeds need to continue to be monitored, managed, and treated.
