### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to COGCC Rule 911 at the PETRIKIN T6N-R64W-S34 L04 Tank Battery location. Laboratory analytical indicated a historical release at the Petrikin A34-08 decommissioned tank battery. One soil sample exceeded COGCC standards for 1-methylnaphthalene at 0.0983 mg/kg, and 2-methylnaphthalene at 0.0514 mg/kg.

Seven grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator (s). Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, soil sample FS01@5' was analyzed for Table 915-1 metals.

If groundwater is encountered the source soil boring will be completed as a monitoring well. Groundwater samples will be collected for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, and inorganic parameters.
