INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The Drake PC MM 14-15 facility is being decommissioned and its associated wells are being plugged and abandoned. This submittal is associated with the closure of the production facility.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Five soil samples will be collected from the produced water sump excavation(s), one soil sample will be collected from beneath each ECD, one soil sample will be collected from under each AST and one at the separator. All samples will be field screened visually and with a PID. In the absence of any elevated PID readings, soil samples collected from the base and one sidewall of the produced water sump excavation(s), each AST, and the separator will be submitted for laboratory analysis of TPH (C6-C36), BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, pH, EC, SAR, and boron. The analytical results will be compared to COGCC Table 915-1. Soil associated with any flowline and dumpline removals will also be field screened visually and with a PID. If any staining or PID readings exceeding background VOC concentrations are observed anywhere onsite or at any field screening location, soil samples from those locations will also be submitted for lab analysis. A soil investigation map is attached.

Proposed Groundwater Sampling

Groundwater is not expected to be encountered during facility decommissioning. If groundwater is encountered, one grab sample will be collected from each area groundwater has accumulated and samples will be submitted for laboratory analysis of BTEX and naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene. Analytical results will be compared to table COGCC 915-1.

One pothole was excavated at an adjacent undisturbed location. Soil samples were collected from 1', 3', and 5' bgs and submitted for reclamation suitability parameters. All background samples were compliant with Table 915-1 reclamation suitability parameters, although one soil sample (TB-BG01@5') approached the upper limit of 8.3 for pH.

No impacts resulting from oil and gas operations were encountered during this investigation.

REMEDIAL ACTION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Sampling was conducted according to the approved Site Investigation and Remediation Workplan. Nine soil samples were collected from the tank battery and separator areas for laboratory analysis of TPH (C6-C36), BTEX, naphthalene, 1,2,4 and 1,3,5 trimethylbenzene, pH, EC, SAR, and boron. All soil samples were compliant with Table 915-1 applicable standards with the exception of samples PW-B01@5' and PW-B01@5', which exceeded the allowable range for pH at 8.41, and 8.42, respectively. Based on the lack of organic compounds and volatiles in the samples, the absence of elevated PID readings and soil staining, and the pH results of the background samples, it is evident that there are no impacts resulting from oil and gas operations at this location and the pH results in samples PW-B01@5' and PW-B01@5' are within range of natural soil variability at this location. Based on the actions taken to date and the laboratory analytical results, no further action is warranted and Bayswater is requesting that remediation number 22020 be closed.
