Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged and abandoned 01/13/2018. Operator has failed to remove gravel from the access road and failed to perform subsequent final reclamation activities (i.e., compaction alleviation, contour, etc.). Operator should have performed all final reclamation activities for the well location and well location access road by 4/13/2018. Refer to the attached inspection photos.
