INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to summarize assessment activities conducted during the closure and removal of one above ground storage tank (AST), one separator, one produced water vessel (PWV), one emission control device (ECD), and one meter house at the Wardell 11-18 O SA facility. The AST, PWV, ECD, meter house, and separator have been permanently removed. Assessment activities began on March 25, 2022. Soil assessment activities were conducted in accordance with COGCC Rule 911.a. A photo log is included as an attachment.

PROPOSED SAMPLING PLAN

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On March 25, 2022, soil samples were collected from the AST, separator, PWV, and ancillary piping (see Figure 1). The soil samples were field screened for total volatile organic compounds using a photoionization detector (PID). Based on PID readings, select soil samples were collected from the AST, PWV, and separator and submitted for laboratory analysis. Analytical results indicated soil was in full compliance with Table 915-1 standards or within the analytical variability of the background samples at the extents of the excavations. Therefore, further excavation was not warranted. The soil sample results and PID readings are summarized in Tables 1 and 2, respectively. The laboratory report is attached.

Eight native background soil sample and one tank battery background sample were collected for laboratory analysis of specific conductivity (EC), sodium adsorption ratio (SAR), pH, boron, and metals. Laboratory analytical results indicated arsenic, barium, and/or selenium are naturally high in the soil used for constructing the tank battery and/or the native soil in the area.
