General Comment:

This is an environmental inspection to document current site conditions at Remediation Project 22660 in response to Complaints 403009272 and 403027565. Any corrective actions from previous inspections as well as Form 19 or Form 27 conditions of approval are still applicable.

COGCC contacted the Operator (Oxy) environmental project manager who met with staff on location at approximately 11am. Operator had a crew working to better secure the location at the time of arrival. The remediation consisted of two excavations exposing groundwater. Both excavations were fenced with a combination of cattle panels and snow fence; both were netted for avian protection. Two unsigned stockpiles were present south of the excavation; Operator indicated they were clean backfill.

Per Operator, kids had recently entered the gated location and were seen playing in the area. In response, Operator repaired and strengthened the snow fence, secured the access gates with twine, and completely surrounded both excavations with caution tape. Per Operator, signage will be added to clean stockpiles.

Operator environmental project manager walked COGCC staff through the remediation progress and discussed potential next steps. Impacts are present at both locations and lab delays have slowed the remediation progress. COGCC agreed to a partial backfill of cleared sidewalls due to the sensitive nature of the site.
