It appears that the previous operator is still displayed on tank battery signage. Install sign to comply with Rule 605.e. (Corrective Action Date: June 3 2022) See attached photo #3.</p> <p>2. It appears that the gas meter has not been calibrated annually. Calibrate gas metering equipment annually to comply with rule 430.d.(1).
