Comment With exception to areas on the stockpiled soils on the north and west ends of the Location, the overall status of interim reclamation for the Location is "in process"; vegetation beyond berms has achieved a uniform desirable vegetative establishment.

Though some desirable plant establishment is evident, it was observed that southern and eastern facing slopes of the soil stockpiles are predominantly a cheat grass monoculture, and not progressing towards reclamation standards.

Corrective Action Comply with 1003 rules and conduct additional reclamation on areas not progressing towards reclamation standards. Comply with Rule 1002.c and implement BMPs at stockpiled soils to prevent weed establishment.
