Rule 603.o. only applies to new and significantly modified Tanks. If the secondary containment is replaced Caerus will comply with all COGCC regulations. Per Rule 902.a. and 912.d Caerus has inspected the location and has not identified a current or historic spill within or around the secondary containment of this location.

Operator Comment: Caerus believes the salt identified on the pad location is the result of background mineral deposits similar to what has been observed immediately off location. Caerus will continue to monitor the site for future changes.

COGCC Decision: **Not Approved**

COGCC Representative: During the field inspection #702800145 on 4/21/22, no other salt staining of this nature was observed on Location. Additionally, it can be observed from the inspection photo that the ground along the secondary containment ring is sloped slightly upwards towards the edge of the secondary containment ring. Given these site characteristics, stormwater would not be expected to accumulate at that location and leave background mineral deposits after evaporation, as might be expected in the area. Caerus should assess the integrity of the secondary metal containments ring and liner to ensure they are not compromised. This can be accomplished by pulling back the pea gravel in this area and inspecting the integrity of the liner.
