Comment: It was observed in this inspection that stormwater sediment and erosion control BMPs on the Location are missing or insufficient to minimize erosion, transport of sediment and offsite degradation; straw wattles are present at the east of the Location. They do not appear to be maintained and sediment was observed to have moved over the top of the wattle. Rills were also present at the east of the Location.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Continue to monitor and manage stormwater on the Location. Ongoing stormwater management is required until the site receives a passing final inspection.
