**General Comment:****COGCC Inspection Report Summary**

On Tuesday 5/10/2022 at approximately 1000, I, Inspector Scott Ramsey, conducted a routine inspection at TEP HM 32-33, at Location # 324290 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

During this inspection the following possible compliance issues were observed:

1. Some areas of cut slope show signs of lack of stabilization/erosion.
2. Valves on tank are missing caps/plugs

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
