Caerus plans to conduct additional investigative soil sampling activities to further delineate and characterize impacts along the southern exterior of the metal containment berm on the working surface of the pad. To better characterize these impacts up to five soil borings will be advanced within and surrounding the release footprint. The soil will be characterized through visual and olfactory observations and field screening the soil using a PID to monitor for the presence or absence of VOCs. See the attached ROWC for additional details regarding the proposed investigation and characterization activities.

Caerus requests a reduced analyte suite to include the analysis for all future samples of arsenic, barium, TPH, BTEX, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, 2-methylnaphthalene, naphthalene, and SAR.

Four representative background soil samples were collected in each cardinal direction outside of the pad disturbance from non-impacted native soil per COGCC Rule 915.e(2). Three of the four background samples were submitted for laboratory analysis of arsenic, SAR, EC, pH, and boron with the exception of the western background sample which was submitted for analysis of all constituents listed in COGCC Table 915-1. Results are included in the attached ROWC.
