INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

The COGCC Orphan Well Program plugged the Margaret Spaulding (OWP) #12-A well and decommissioned the wellsite during the summer of 2021. Soil samples were collected in accordance with the Initial Form 27 for the project and COGCC Rule 915.e(2)B. Five soil samples, including one project background sample, were collected from the site; one was collected from the wellhead excavation, one was collected from the under the former triplex pump, one was collected from the under the former pumping unit, one was collected from the flowline excavation, and one (background) was collected from nearby, non-impacted native soil. All samples were submitted for laboratory analysis of Table 915-1 constituents.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

All areas suspected of having potential impacts, including the wellhead, associated flowline(s) (if present), and production equipment (if present), were visually inspected and field screen with a PID. Using these observations and field screening results, soil samples were collected from areas most likely to be impacted.

One discrete soil sample was collected from the wellhead excavation, one discrete soil sample was collected from under the former triplex pump, one discrete soil sample was collected from under the former pumping unit, and one discrete soil sample was collected from the flowline excavation. All samples were submitted for laboratory analysis of Table 915-1 constituents. The attached project map provides the location of all samples.

No groundwater or pathways to groundwater were discovered during the plugging and decommissioning activities. As such, no groundwater samples were collected for this project.

One representative background soil sample was collected for the project from nearby, non-impacted native soil. Laboratory results indicate the pH value was outside of the COGCC standard. Additionally, arsenic concentrations exceeded the COGCC standard.

Soil sample SS01, collected at a depth of 0-0.25 feet below ground surface (bgs) from the wellhead excavation, had TPH values exceeding the COGCC Table 915 standards. Soil sample SS02, collected at a depth of 0-0.16 feet bgs from under the former triplex pump had TPH, 1-methylnaphthalene, benzo (b)fluoranthene, and benzo(a)pyrene values exceeding the COGCC Table 915 standards. Soil sample SS03, collected at a depth of 0-0.33 feet bgs from under the former pumping unit had TPH and benzo(a)pyrene values exceeding the COGCC Table 915 standards. Soil sample SS04, collected at a depth of 3 feet bgs from the flowline excavation had TPH; 1,3,5-trimethylbenzene; and benzo(a)pyrene values exceeding the COGCC Table 915 standards. Further excavation/remediation of impacted soils within these areas may be required.

Arsenic also exceeded the COGCC Table 915 standard in all samples, but was relatively consistent with background concentrations.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

The well was plugged and the wellsite decommissioned during the summer of 2021. Soil samples were collected in accordance with the Initial Form 27 for the project. Based on Initial Form 27 soil sampling results, it appears additional remediation is needed in the vicinity of the former wellhead, triplex pump, pumping unit, and flowline. It is estimated that approximately 40 or more cubic yards of soil should be excavated and disposed of at an approved facility. Please refer to attached Results Table, Map, and Photographs.
