On 5/16/2022, Reclamation Specialist Trujillo conducted a stormwater inspection at Caerus Piceance's N. Parachute-65S95W 29SENE (H29A) location in Garfield County, Colorado.

This inspection is a followup to No. 696202450 dated 3/9/2021, and No. 696203600 dated 4/22/2022 to document compliance with the following corrective actions:

-1002.f Stormwater

It was observed in this inspection that the Location remains out of compliance with COGCC Rules and corrective actions.

The following new compliance issues were observed during this inspection:

- 606: Debris

Comment: Previous inspections observed BMPs at slopes on the north end of the Location were missing or insufficient. Inspections required Operator to comply with Rule 1002.f by 5/6/2022.

It was observed in this inspection that control measures to minimize erosion, degradation, and to stabilize the slopes on the north end of the Location are missing or insufficient; inspection #696203600 observed control measures (hydromulch) in disrepair; hydromulch no longer evident; no additional controls appear to have been implemented; erosion degradation and stabilization issues at the slopes have persisted.
