General Comment:

On 05/13/2022, Reclamation Specialist O'Malley conducted a reclamation and stormwater inspection at Beeman Oil & Gas LLC's Bulldog /5-14H-789 Location #429647 in Moffat County, Colorado.

The following compliance issues were observed during this inspection:

- Location signage absent or with incorrect Operator information
- Wildlife protection BMPs absent
- Open casing at wellhead
- Unmarked guy line anchors
- Interim reclamation not performed
- Noxious weeds: houndstongue, thistle spp.
- Stormwater: erosion degradation at stormwater BMPs

Refer to the "Location," "Reclamation," and "Stormwater" sections of this inspection report for additional details.

Refer to the photo-documentation of the observed compliance issues attached to this report.

Any corrective action(s) from previous inspections that have not been addressed are still applicable.

Comment Location received a "Notice to Operators: Interim Reclamation Procedures for Delayed Operations" variance request Doc #401291897 to delay interim reclamation for 5 years. Surface owner letter dated 05/01/2017. A corrective action date of 05/01/2022 is being provided as this is when interim reclamation was required. It was observed in this inspection that all permitted wells have been drilled. The Location is subject to Interim Reclamation pursuant to 1003 rules.

It was observed in this inspection that Noxious weeds were present throughout the Location including Canada and bull thistle and houndstongue (CO List B Noxious weeds).

Corrective Action **CORRECTIVE ACTION #1: Conduct interim reclamation on the Location per 1003 Rules including, but not limited to: gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities; use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district. Comply with Doc #400281942 COA 7. Implement control measures to stabilize the seeded soil per Rule 1002.d.(2)C. CA date: 05/01/2022.**

CORRECTIVE ACTION #2: Comply with Rule 1003.f and conduct weed management on the Location to prevent further establishment and spread of CO State List B Noxious Weeds; ongoing weed management required. CA date: 06/01/2022.

Comment: It was observed in this inspection that BMPs to manage stormwater and sediment have not been maintained in proper functioning condition and are contributing to degradation of the Location and adjacent areas. The stormwater berm at the west of the Location and the drainage pipe at the southwest of the Location are not properly designed or maintained in proper functioning condition. Stormwater has incised the perimeter berm in both areas resulting in large gullies. Additionally, the perimeter ditch to the southwest of the Location is eroding, resulting in the formation of a gully.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Continue to monitor and manage stormwater on the Location. Ongoing stormwater management is required until the site receives a passing final inspection.
