Comment: **The access road has not been recontoured and the cattleguard and culverts remain. The location has not been reclaimed and there is an area approximately 150'x100' with no vegetation. The electric utilities and fence remain and are in disrepair. All equipment should have been removed within 3 months of abandonment and reclamation completed within 12 months. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.**

All disturbed areas must be recontoured, properly decompacted by cross ripping to a depth of 18 inches, have an adequate seedbed prepared, and then seeded with a seed mixture that reflects the surrounding vegetation. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Continue to monitor and maintain the location until the final reclamation requirements are achieved.	CostaR	05/19/2022
