INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the closure of one above ground storage tank (AST), one produced water vessel (PWV), one emission control device (ECD), one meter house, and one separator at the Lot O 15-16 O SA Facility. The AST, PWV, ECD, meter house, and separator will be permanently removed as depicted on Figure 2. In accordance with COGCC Rule 911.a., soil samples and a groundwater (if present) sample will be collected following removal of the AST, PWV, ECD, meter house, and separator to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Field screening of soils will be conducted during equipment removal activities. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following the facility decommissioning activities, discrete soil samples will be collected from the surfaces and excavation area(s) in accordance with COGCC Operator Guidance - Rule 911.A.(4) - Oil and Gas Facility Closure and Rules 913 and 915. If impacted soils are encountered, a waste characterization soil sample will be collected from the area(s) exhibiting the highest degree of impact based on visual, olfactory, and/or field screening observations. In the absence of apparent impacts, soil samples will be submitted to an accredited laboratory for analysis using standard methods appropriate for detecting the target analytes in COGCC Table 915-1. Proposed soil sample and screening locations are provided on Figure 2.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during facility decommissioning activities, a minimum of one grab sample will be collected as soon as practical. Groundwater samples will be submitted to an accredited laboratory for analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, using standard methods appropriate for detecting the target analytes in COGCC Table 915-1.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

If no impacts are observed following removal of the equipment, soil samples will be submitted from the locations as applicable under COGCC Operator Guidance Rule 911.a.(4) for laboratory analysis of BTEX, TMBs, naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D. A minimum of one sample will be collected from the root zone (0-3 feet bgs) and submitted for laboratory analysis of pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water-soluble soil extract method. If impacts are encountered, the soil samples will be submitted for laboratory analysis of the full COGCC Table 915-1 analytical suite.
