**General Comment:****COGCC Inspection Report Summary**

On Monday 5/23/2022 at approximately 1200, I, Inspector Scott Ramsey, conducted a routine inspection at TEP GV 25-27, at Location # 311574 and RWF 331-27, location # 335380 in Garfield county Colorado. The wells are on a shared location.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management, Geologic Hazard area. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

All equipment is anchored.

During this inspection the following possible compliance issues were observed:

1. Some areas of location show signs of lack of stabilization/ compaction/ degradation
2. Well head fence panel and entrance are on ground.
3. Valve on tank missing cap/plug.

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
