Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6582'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perms @ 6632')
4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.
5. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.
6. Unland casing and perform stretch calculation confirming surface squeeze can be executed. Adjust squeeze holes and cement as necessary.
7. TIH with perf gun. Shoot squeeze holes @ 490'.
8. TIH with tubing to 1690'. RU cementing company. Mix and pump 128 sxs 15.8#/gal CI G cement down tubing. (Pierre Coverage from 1690' to surface) Cement should circulate to surface.
9. Close off casing returns. Hook up cement line to cement flange and pump 104 sxs 15.8#/gal CI G cement downhole and squeeze through perms @ 490' into annular space. Cement should circulate to surface.
10. Well casing cut and capped per COGCC guidelines at a depth as not to interfere with soil cultivation.
