Good Morning Alex,

The pictures are WC#31 and we did see where Urie got to close to the edge with their non impacted spoil pile, I did have them go back and pull it away from the edge so we could get our waddles in behind it. With asking him to come back and pull it away from the edge, I certainly reminded them not only watch our edges but, we also have to have room to put in our waddles without hanging off the edge of the mountain with ropes, so I think we got that resolved going forward and even though it's not impacted we will be recovering it when we start reclaim, as we need it up top. Again we have addressed it with the contractor, Thank You very much for shooting us a note, I'm sure you guys were able to see we are working on the inspection items from a couple of weeks ago, we just ran out of waddles, but we have a shipment coming in next week. We continue to get all chemical totes and containment removed from all sites, making sure their flushed and all containment are stored and upside down so no wildlife can be trapped.
