Comment:

At the well location, it appears operator has performed corrective action reclamation activities, with the evidence of drill rows and straw crimped mulch. Germination of desirable species was observed throughout the disturbance area. Alfalfa has not re-established fully and well pad will remain in process until alfalfa has re-established or crop field has been repurposed. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management

The tank battery location appears to meet final reclamation regulations and standards, and appears reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.
