<p>Stormwater Comments</p> <p>Previous inspection nos. 700702906 and 702800144 observed the berm behind separators undermining. Inspector required Operator to install or repair required BMPs by 7/30/2021. It was observed in this inspection that the berm behind the separators had been repaired, although no control measures were observed to prevent the issue from reoccurring, as happened previously. This corrective action has been addressed.</p> <p>Previous inspection no. 702800144 observed erosion degradation is evident throughout the interim areas to the north of the Location. Water flow patterns are present throughout the area and large gullies are present. Interim area vegetation is insufficient to stabilize the Location. Inspector required Operator to install or repair required BMPs by 7/30/2021. Operator submitted FIR Resolution #403051335 stating "Raked and seeded all erosion throughout location." It was observed in this inspection that areas of erosion on the Location appear raked. No control measures were observed to stabilize either the unprotected soil or the seed. Rill erosion was reoccurring in this same areas where it was previously observed, where raking and seeding had been implemented. Stormwater and sediment control measures are insufficient; erosion continues.</p>	omalleya	06/06/2022
