1	Drilling/Completion Operations	Multi Well Open-Hole Logging - Rule 317.p: Alternative Logging Program: One of the first wells drilled on the pad – Barton Mills 8-67-29-30C (API 05-123-46456). The first well drilled on this pad has been logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. That info is attached to form 5 Doc# 402375120. All proposed wells related to this permit will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached.
