Comment:

The well on Location (API # 103-06037) was plugged and abandoned 9/16/1994. Per COGCC Rules reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities.

It was observed in this inspection that Final Reclamation has not been performed. The Location appears compacted from vehicle traffic, and the only vegetation present is the annual weeds comon dandelion and stork's-bill. The date of discovery is being given as a corrective action date.

Corrective Action:

Submit a Federal Abandonment Notice (FAN) in a FIRR indicating surface reclamation has been passed per Bureau of Land Management standards, or complete final reclamation activities pursuant to COGCC 1004 Rules including, but not limited to, gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities on the Location and access road. Use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.
