	<p>The well location does not comply with Rule 1004. The majority of the well pad disturbance shows sparse stunted crop growth and is not reflective of the reference areas.</p> <p>At the tank battery location, the operator has performed corrective action reclamation activities, with the evidence of drill rows and straw crimped mulch. Germination of desirable species was observed throughout the disturbance area. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Operators shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards.</p>	
Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.</p> <p>The corrective date is not intended to be the date for which the Operator shall complete the corrective actions but rather the corrective date is the date the location was observed out of compliance.</p>	Date 05/19/2022
