A site investigation was conducted pursuant to COGCC Rule 911 at the FRANK T4N-R64W-S12 L02 Tank Battery location.

Ten (10) grab confirmation soil samples were collected from the produced water vessel excavation, beneath the ground oil tank, and at the separator. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The COGCC Tank Battery and Produced Water Vessel Closure Checklist was utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

A Site Assessment was conducted on 5/13/2022 to delineate impacted media. Five soil borings were advanced in the area of impacts. Soil samples were collected and analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil, metals in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Five groundwater monitoring wells were installed in the borehole locations. Groundwater samples were collected and analyzed for COGCC Table 915-1 Organic Compounds in Groundwater and Groundwater Inorganic Parameters. Upon receipt of the site assessment lab data, a subsequent Form 27 will be submitted.
