Comment:

It was observed in this inspection that the revegetation of the Location has met 1004.c.(2) standards; desirable perennial vegetative establishment is uniform and reflective of the adjacent reference area. Historic aerial imagery shows access road pre-existed the Location, and is not subject to 1004 Final reclamation requirements.

It was also observed in this inspection that surface equipment (pipe risers) has not been removed from the Location. Well was abandoned 7/21/2016; pursuant to Rule 1004.a, all risers and surface equipment is required to be removed within 3 months of plugging a well; risers/equipment was required to be removed by 10/21/2016.

Perimeter fence equipment also requires removal for final passing.

Corrective Action:

Comply with Rule 1004.a and remove riser/surface equipment, as well as perimeter fence. Upon removal, submit date-stamped photo documentation attached to a FIR Resolution Form to show corrective action has been addressed.
