General Comment:**COGCC Inspection Report Summary**

On Wednesday 6/15/2022 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at TEP RWF 331-11, at Location # 335638 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

During this inspection the following possible compliance issues were observed:

1. Some valves on tanks are missing caps/plugs.
2. Some areas of location and access road show signs of lack of stabilization/ erosion/ degradation.
3. Some erosion is occurring behind tank battery, waddles are also failing with sediment migration.

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
