<p>Final Reclamation Comments</p> <p>Operator submitted doc #403042925 stating "Final Reclamation will commence approximately 5/27/2022." Per 1004 Rules, reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities. Final Reclamation includes but is not limited to gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities on the Location and access road. Use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.</p> <p>It was observed in this inspection that the Location was previously seeded with non-native species which do not match reference areas. Per 1004 Rules vegetative cover should reflect reference area forbs, shrubs and grasses and the Operator must use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.</p> <p>Risers, pipes and power lines were observed to the south and east of the Location. All equipment associated with the Location must be removed along with all stormwater ditches, berms, impoundments and other stormwater BMPs and areas impacted by removal must be reclaimed to pass final reclamation.</p>	omalleya	06/15/2022
