 Field Inspector Actions:
 On 6-13-2022, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Noise. The complainant Kimberly Allen 1065 W 154th ave Broomfield CO stated the issues were occurring outside of complainants home.
 On 6-14-2022, I attempted to make contact with the complainant who indicated hearing extreme loud noise inside residence.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, Frac crew was not actively fracing. Crew was moving from Interchange A pad to Interchange B pad. I did ask Civitas for their third party sound data once they started fracing again. Sound data is 6-16-22 7PM to 6-17-22 7AM. After reviewing data it does not appear to be out of compliance. Sound data is attached to complaint inspection.
