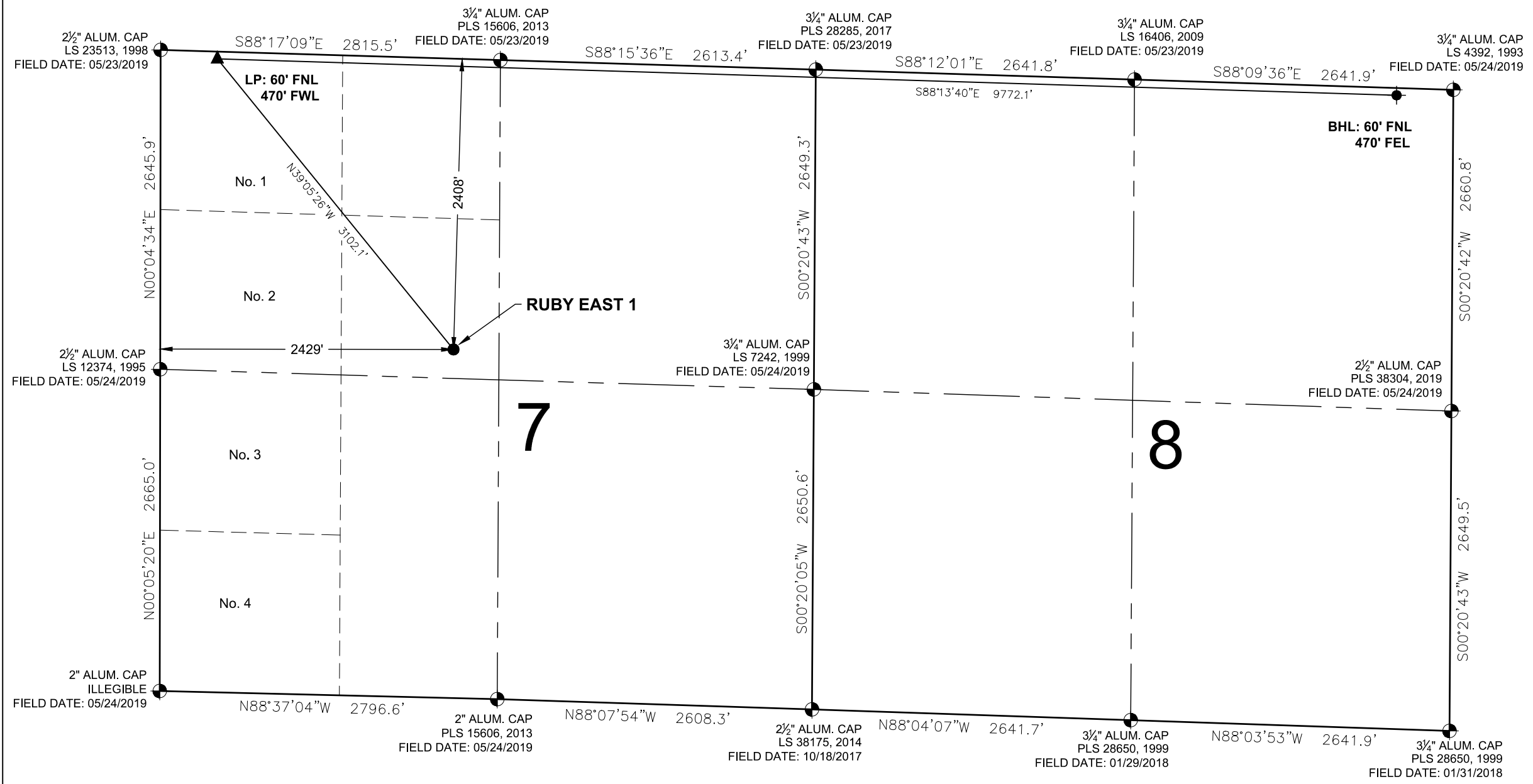


RUBY EAST 1 WELL LOCATION CERTIFICATE

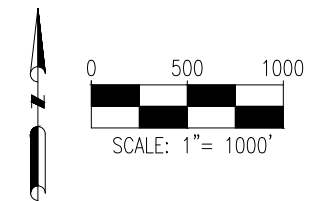
