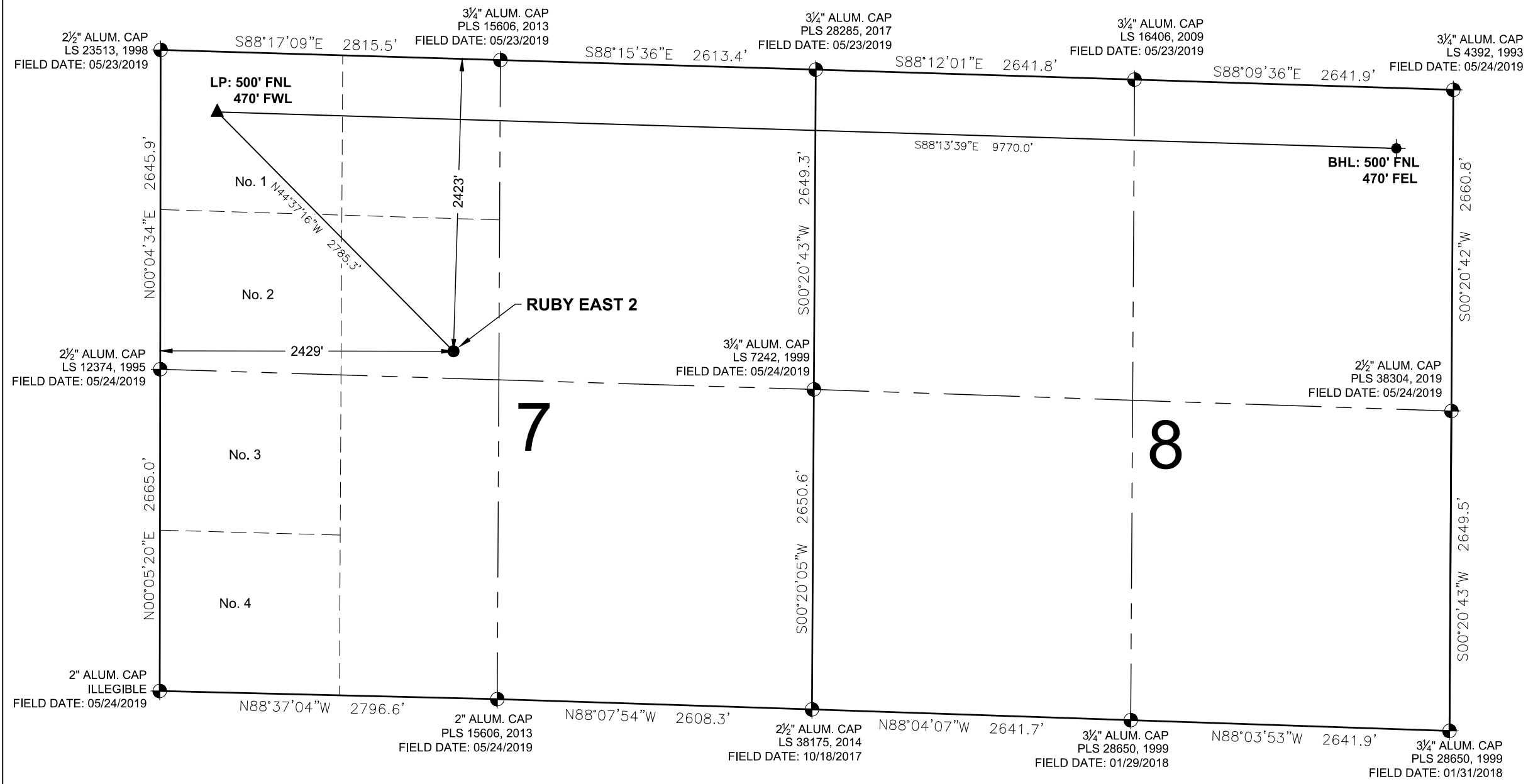


RUBY EAST 2 WELL LOCATION CERTIFICATE

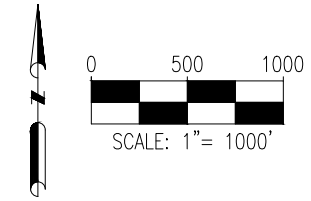
