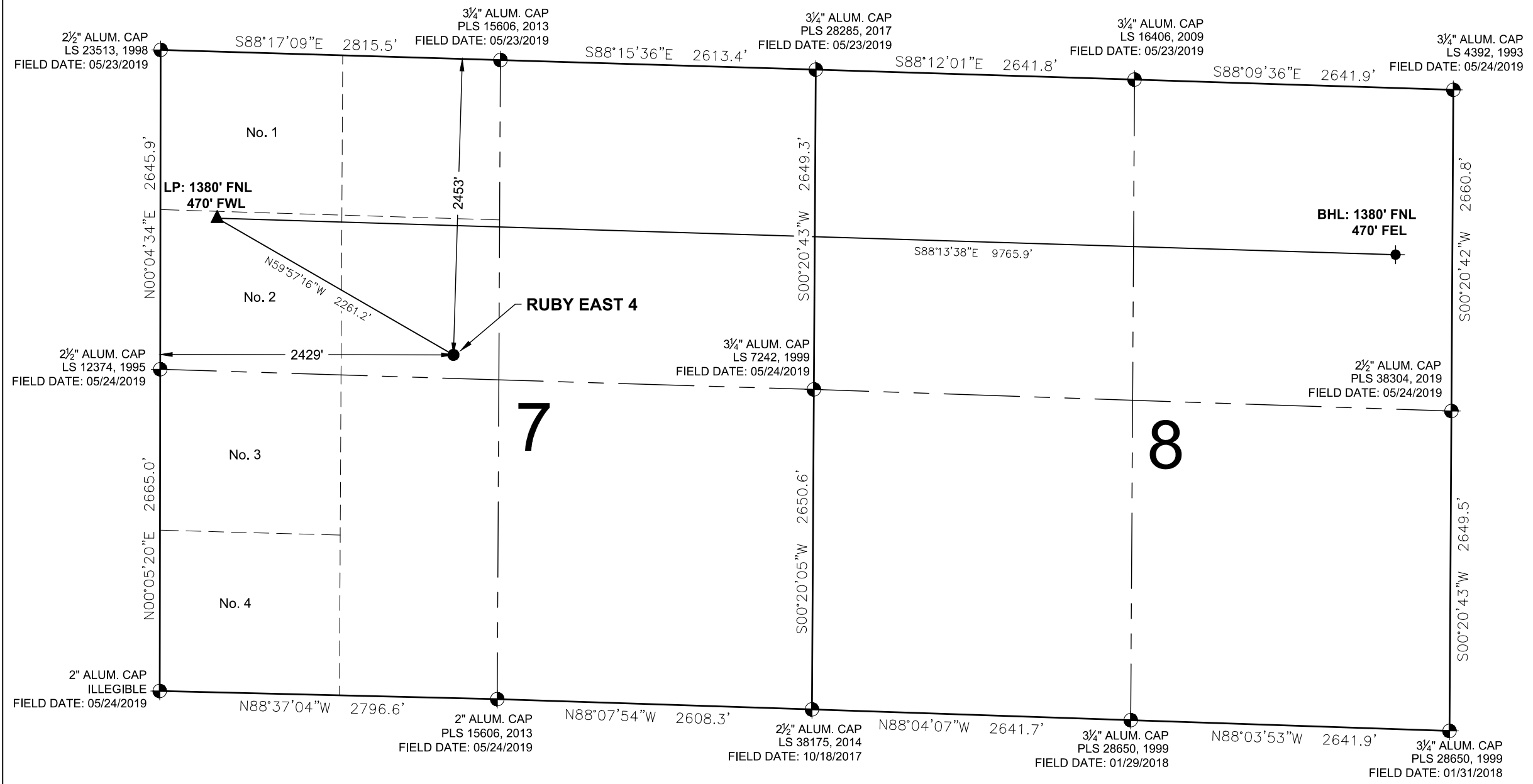


# RUBY EAST 4 WELL LOCATION CERTIFICATE

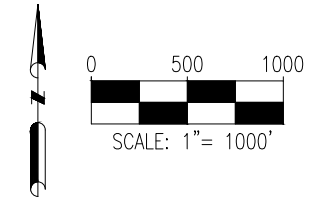
