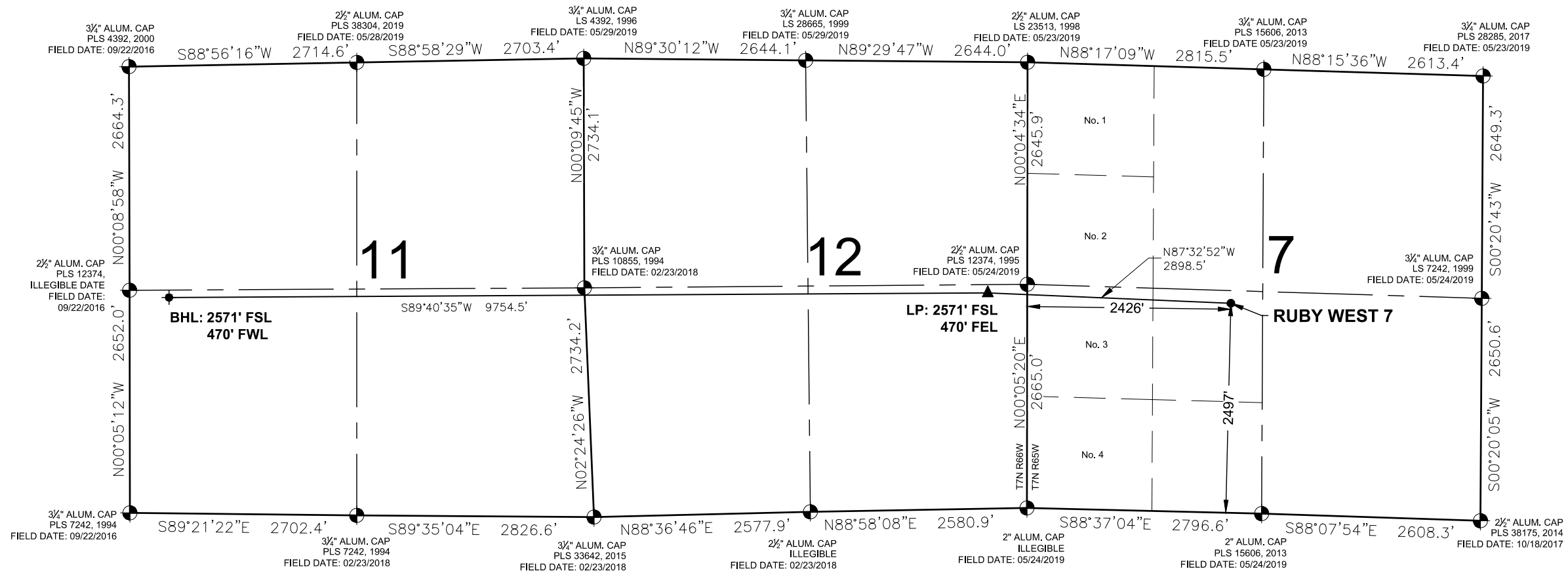


RUBY WEST 7 WELL LOCATION CERTIFICATE

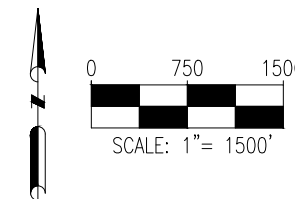
